Dear Dr. Dale:

On behalf of the Fairfax County Athletic Council, I would like to thank Fairfax County Public Schools for its support of community athletics in the county. As the Athletic Council member-at-large, I represent new and emerging sports. Badminton is an emerging and rapidly growing sport in the county. Therefore, I have been working with the Department of Community and Recreation Services (CRS) to provide badminton space to the community at middle school gyms.

In general, Fairfax County middle school gyms are not designed for badminton, which requires a 24-foot high ceiling, but the floor surface used at new and renovated schools is adequate. While I understand that building structures cannot be readily modified to accommodate the height requirement for badminton, installing the standard floor layout for badminton courts which is 44' x 20' (please see the attached diagram) in middle school gyms would pose no significant costs to the schools either being renovated or built. While Holmes and Kilmer Middle Schools both have standard badminton layouts, other middle schools do not. A good example is Key Middle School, which was renovated in 2006-2007. During the renovation, six 39-foot-long badminton courts were installed in the Key Middle School gym. Instead of the 39-foot courts, it would have cost nothing extra to design six standard 44-foot-long badminton courts.

I understand that the badminton community's problems cannot be addressed all at once or overnight, but the badminton community has been very patient and has tried to become constructively engaged in the sports community. When I inquired whether future renovations of middle school gyms would include badminton layouts, I was told that the schools do lay out standard badminton courts as that sport is not played in the middle schools. However, the schools are a community asset and the community plays badminton.



Therefore, the Athletic Council requests that future renovations of middle school gyms include standard layouts for badminton courts. This policy would not impact the cost of renovation and would facilitate further development of badminton in the county. If more courts were available for badminton use, CRS would have additional options for scheduling badminton groups and would be better able to meet geographic needs. CRS would also be able to make adjustments when schools become unavailable due to maintenance or school activities.

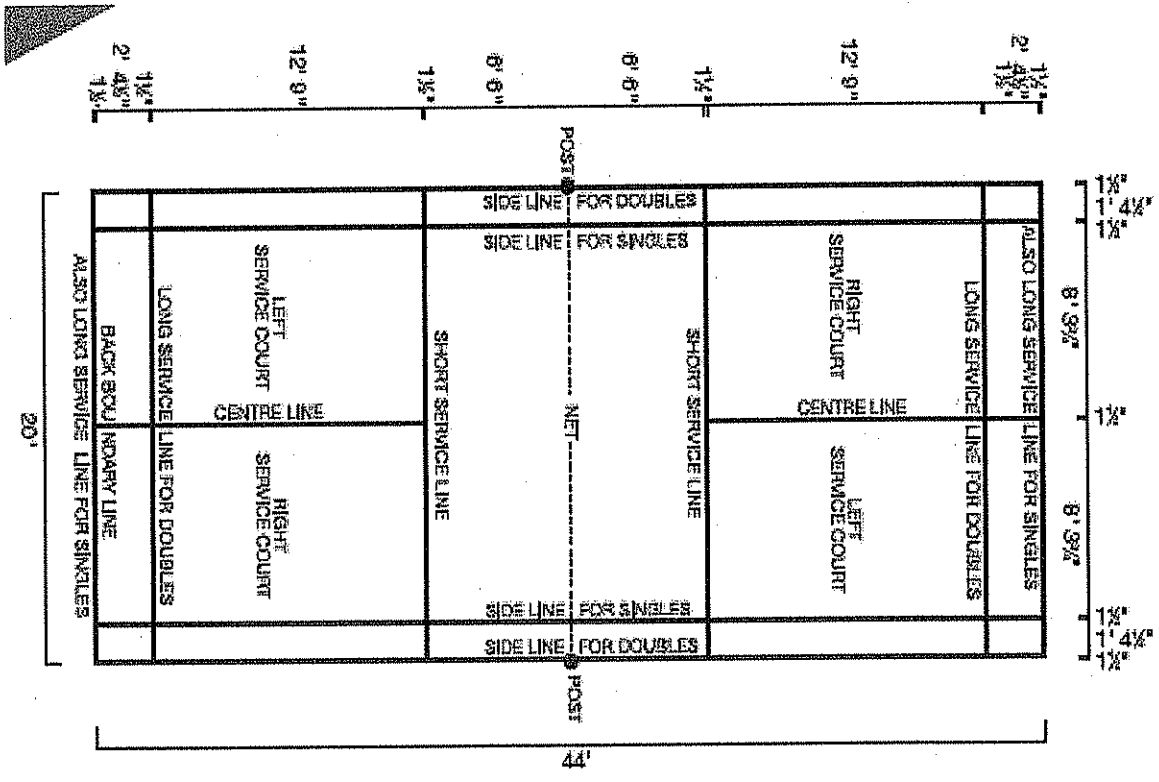
